Dog Registration:

Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee. You may register your dog online at <http://nasda.dog/registration/>.

Rules:

Please make sure to familiarize yourself with the rules prior to the trial. The complete rules can be found at nasda.dog

Venue:

There will be a port-a-potty available for use. There is no smoking and/or vaping allowed at the trial site outside of your vehicle. No alcohol is allowed on the premises. Please make sure to pick up after your dogs. K-9 Scent Crew reserves the right to remove any individual for any reason from the premises. No refunds will be issued.

Crating:

Exhibitors will be crating from their vehicles. The trial site is not shaded so please make sure you bring fans, shade cloths, etc. to keep your dog's cool & comfortable. If the weather is cold, bring what you need to keep you and your dog warm in the vehicle. Dogs must be crated or kept comfortably in your vehicle while not running or pottying.

Parking:

There will be signs and/or someone to direct you to the parking area. Please watch for cones or signs indicating an area is off limits for parking.

Food:

There will be no food available at the trial site and no restaurants close by. Please make plans to bring your own food.

Accessibility:

The trial will be held outdoors on a rural, working farm. The terrain has a moderate slope with areas of uneven footing, natural brush and wildlife. Please contact the trial secretary at luvmypet@bellsouth.net if you need more information.

Schedule/Times:

Competitors may arrive starting at 7:45 am each day. Check-in will begin at 8 am. General/Judge's briefing at 8:15 am. First dog on the line at 8:30 am.

Awards:

Awards will be handed out at the conclusion of the trial. Ribbons are awarded for qualifying scores, Best of Breed and High in Class. New title ribbons will also be available.

COVID Guidelines:

Specific COVID precautions will be announced, if needed, closer to the trial date via email. It is likely that there will be a COVID waiver that everyone attending the trial will need to sign. In the event that some of the Urban searches are conducted in an interior setting, CDC guidelines regarding masks will be used to inform our decision making about any masking requirements for those searches.

Notice to Exhibitors:

- Refunds will be mailed 7 days after the event.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$25 fee for any returned check or payment.
- A final email confirmation will be sent out to competitors sometime during the week prior to the trial date with additional information.
- K-9 Scent Crew reserves the right to refuse any entry without cause or explanation.
