Dog Registration:

Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee of \$25.00. You may register your dog online at <http://nasda.dog/registration/>.

Venue: We may be using different areas of the camp for searches. The main outdoor area will have a Port a Pot for handlers' use. If we do searches at the Lodge, indoor restrooms will be available at that location. No smoking and/or vaping is allowed at the trial site. No alcohol is allowed on the premises. Please make sure to pick up after your dogs. K-9 Scent Crew reserves the right to remove any individual for any reason from the premises. No refunds will be issued.

Crating: Exhibitors will be crating from their vehicles. The parking lot is not shaded so please make sure you bring fans, shade cloths, etc. to keep your dogs cool & comfortable. If the weather is cold, bring what you need to keep you and your dog warm in the vehicle. Dogs must be crated or kept comfortably in your vehicle while not running or pottyng.

Parking: There will be signs and/or someone to direct you to the parking area. Please watch for cones or signs indicating an area is off limits. Parking may be on grass, gravel or asphalt. You may also be parked along the Camp road.

Food: There will be no food available at the trial site and no restaurants close by. Please make plans to bring your own food and beverages.

Accessibility: The parking lot is a rough dirt/gravel lot. The pathways and search areas may require you to navigate gravel roads, dirt and or rocky pathways in the woods and rough terrain in wooded areas. The search areas and parking lot are spread out so there may be long walks to the search areas that will involve moderate elevation changes. Please contact the trial secretary at lurvmpet@bellsouth.net if you need more information.

Schedule/Times: Competitors may arrive starting at 7:45 am each day. Check-in will begin at 8 am. General/Judge's briefing at 8:15 am. First dog on the line at 8:30 am. The tentative schedule will be S/D, T/L, T/B, U/L & L/I (may be subject to change). The classes will be run consecutively by level- i.e. S/D Level I (Trials 1/2/3), S/D Level II (Trials 1/2/3) and S/D Level III (Trials 1/2/3), etc.

Awards: Awards will be handed out throughout the day as classes are completed and scores are finalized. Ribbons are awarded for qualifying scores, Best of Breed and High in Class. New title ribbons will also be available. ****IMPORTANT** If you are expecting any Versatility or Master Champion titles, please inform the trial secretary asap at lurvmpet@bellsouth.net.**

Dogs in Season: Females in season may participate wearing appropriate britches at all times except in the toileting areas. Females in season will run after the last dog in each search area. Handlers must notify the Trial Secretary as soon as possible so accommodations may be made for toileting areas and run order adjustments.

Hotels: We have made no arrangements with any local hotels. Please make sure to pick up after your dog(s).

COVID Guidelines: Specific COVID precautions will be announced, if needed, closer to the trial date via email. It is likely that there will be a COVID waiver that everyone attending the trial will need to sign. In the event that some of the Urban and Lost Item searches are conducted in an interior setting, CDC guidelines regarding masks will be used to inform our decision making about any masking requirements for those searches.

Other Health Issues: Please do not plan to attend the trial if either you or your dog is sick on the day of the trial. Please be mindful of the recent reports of a potential new respiratory illness in dogs that can be spread by coughing or sneezing. If your dog is experiencing those symptoms, it will not be appropriate for them to participate.

Notice to Exhibitors:

- No refunds for cancellations after the closing date.
- No refunds for entries that are absent, disqualified, excused or barred from competition by decision of the judge and/or hosts.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the judge and/or hosts, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$25 fee for any returned check or payment.
- A final email confirmation will be sent out to competitors sometime during the week prior to the trial date with additional information.
- K-9 Scent Crew reserves the right to refuse any entry without cause or explanation.
