Entries are <u>limited</u> to 125 searches for Novice, 50 searches for Advanced and 50 searches for Excellent. Entries will be accepted on a first received basis until elements fill.

By registering for this trial, you agree to the Release of Liability Waiver at the end of this document.

CANCELLATIONS / MOVE UPS / CHANGES:

- Cancellations received on or before Wednesday, November 29th, full refund
- Cancellations received on or after November 30th, there is **NO** refund. Requests for changes or refunds must be made via email to the Trial Secretary no later than November 29th. After that date, no changes or refunds will be made.
- If you earn a title in the entered element before this trial, please contact the Trial Secretary no later than Sunday, 12/03/2023 in writing via email for move ups.
- Move-ups- The only move-ups available at this trial will be from Saturday Novice to Sunday Advanced elements if there are "day of" entries available on Sunday. These will be offered at regular price, not "day of" pricing.
- Please remember that you cannot enter a level in Standard or Pro for which the dog is not yet qualified in anticipation of earning a title and moving up.
- FEO Runs- FEO runs are allowed at this trial regardless of what level the dog qualifies to run.

INFO SPECIFIC TO THIS TRIAL:

Facility and Restrooms: The facility is climate controlled with indoor restrooms. There is no smoking and /or vaping allowed at the trial site outside of your vehicle. No alcohol is allowed on the premises. Access to the restrooms in the main Lodge may be delayed at times depending on where searches are occurring. It may require someone to wait through a couple of searches before they go in and wait a few minutes to exit the building, in order not to disturb a search.

Trial Site: Please do not visit or contact the trial site prior to the trial date. No training should take place at the trial location. Please be respectful of this wonderful site and pick up after your dog.

Accessibility: The parking lot is a rough dirt/gravel lot. The pathways and search areas may require you to navigate gravel roads, dirt pathways in the woods and rough terrain in wooded areas. There are steps to enter the Lodge, which will be used for some searches. There may be searches on the 2nd floor of the Lodge. The only way to access the 2nd floor is a stairway. The search areas and parking are spread out so there may be long walks to the search areas that will involve moderate elevation changes.

Parking: There will be signs and/or someone to direct you to the parking area. Please watch for cones or signs indicating an area is off limits for parking-it may be a search area. We will enforce our arrival times for competitors in order to make sure parking is orderly. This will be particularly important on Saturday when we are expecting more vehicles. The parking lot is small, but definitely large enough for the number of vehicles for this trial. If you want to park next to someone in particular, you should arrange to arrive at the same time, since we will direct each person to a specific spot.

RVs: No RV parking will be allowed at this trial due to the limited size of the parking lot.

Crating: Indoor crating is **NOT** available at this site. Be prepared to crate your dogs in your vehicles. Bring shade cloths, fans, water and anything else you need to keep your dogs comfortable. No tents can be used in the parking lot.

Volunteers: If you are interested in volunteering, please fill out the form near the bottom of the premium. Half day volunteers will receive \$10 in Crew Cash. Full day volunteers will receive \$25 in Crew Cash and lunch will be provided. Depending upon where you are volunteering, you may be placed at the front or end of the running orders. If the response for volunteers exceeds the needs, we may not call on you to volunteer. We will likely give priority to full day workers. We greatly appreciate our volunteers and thank you so much!

Food: There will be no food available at the trial site. There are fast food restaurants in Gallatin, which is about 15 minutes away. However, we would encourage you to stay at the trial site until all of your searches are complete, if at all possible.

Grandfathering Legs and Titles from PSD: If you would like to grandfather in the legs and titles your dog has earned while trialing in PSD through November, 2021, please include a PDF or screenshot of your dog's titles and qualification history from the PSD web site along with your mail-in entry. If the KSG records do not indicate that you qualify at the level that you are entering and you have not provided information from your PSD legs or other venues listed below, your entry will not be processed until that is resolved.

Dogs who have passed an ORT from NACSW may waive the SIT's for those odors. Dogs who have earned an NACSW NW3 title or an Excellent Overall title from either AKC or UKC may skip Novice level and begin at Advanced. Retired professional detection dogs may also skip Novice and enter in Advanced provided they pass the SIT's for all three odors or show proof of passing an ORT for all three odors. Proof must be emailed to the trial secretary prior to the event at <u>luvmypet@bellsouth.net</u>.

TRIAL ENTRY METHOD: All entries must be made by MAIL for this trial. The entry forms can be found at the end of this Premium. Entries received before the opening date will not be processed.

All dogs must be registered with an "Active" status to be entered. You can register your dog at <u>www.k9scentgames.net</u>. Please note that if online dog registration is not available at the time you mail in your entries, a form has been provided at the end of this premium. Complete the form and include a separate check for \$35.00, made out to K9 Scent Games, and include it with your entries.

5) If you earned/won Crew Cash or Worker Bucks from earlier K-9 Scent Crew events, please enclose the certificate & remember to subtract the amount from your total entries due.

Your entry will not be processed without payment. There will be a \$25 service fee for any returned checks. Checks will be deposited on or after the closing date of November 29, 2023. If you withdraw before the closing date, your check will be shredded. If you make a partial withdraw before closing, we will issue you a check at the trial, refunding the difference. You may also choose to send a replacement check and we will shred the original.

GENERAL KSG TRIAL INFO:

Facebook Group: A Facebook group will be created specifically for this trial to post important information. The judges' video debriefings will also be posted in the group. You will receive more details via email closer to the trial.

General/Judge's Briefing: The briefing will be sent via email and will also be posted in the Facebook group on Friday evening after the final walkthrough with the judges. There will be a short in-person briefing and introductions to kick off the trial before the first dog runs. We will post video judges' debriefings after the trial on the Facebook group.

Ribbons: Rosette placement ribbons will be awarded for 1st - 3rd place in the Standard division as well as new titles. Double-layer placement ribbons will be awarded for 1st - 3rd place in the Pro division as well as new titles. Ribbons will be awarded for qualifying searches in all elements in the Standard and Pro divisions as well as for SITs.

Golden Nose Award: We are excited to offer special recognition for those dogs who had an exceptional trialing day! To qualify for this coveted award, a dog must qualify in all 5 elements offered that day regardless of the level or division (Standard & Pro) in Novice, Advanced or Excellent. SITs and FEO runs are not counted toward qualifications for the Golden Nose award.

For example: Spot is entered in Advanced Interiors, Solo and Containers as well as Novice Fast Finds and Exteriors. Since Spot is entered in all 5 elements, regardless of level, he is a contender for the Golden Nose award.

For example: Since Advanced is not being offered on Sunday, if Spot is entered in Novice Fast Finds and Novice Exteriors, Spot would need to be also entered in Pro Novice Interiors, Solo and Containers.

Moo Tips Jar Award: One dog will be chosen from all the dogs that earn a Golden Nose Award during one trial day to receive this fun award- a personalized jar filled with all the swabs used at the trial that day signed by the Host and the Judge!

Awards: Ribbons and summary sheets will be distributed after all placements are tallied.

Spectators will generally be welcomed at KSG trials. However, as we continue to deal with the changes in the COVID pandemic, decisions regarding spectators will be made closer to trial date.

Collars: Any collar is allowed on the grounds except scent spraying collars and electronic collars. Only a flat, or martingale collars or limited slip collars or leashes attached to a dead ring or harness are permitted to be used during a search. <u>No hanging tags</u> on collars or harnesses while searching. No retractable leashes are allowed except in the search areas. All dogs must be leashed at all times, except during an off-leash search.

Dogs In Need of Space: A red bandana can be used for reactive and dogs in need of space, if desired, but **please give all dogs space**.

Dogs in Season: Females in season may participate wearing appropriate britches at all times except in the toileting areas. Females in season will run after the last dog in each search area. Handlers must notify the Trial Secretary as soon as possible so accommodations may be made for toileting areas and run order adjustments.

Handler running multiple dogs: A handler may only run one dog in each element or SIT test. A second or third dog can run FEO or in a different element or SIT test.

COVID Guidelines: Specific COVID precautions will be announced, if needed, closer to the trial date via email. It is likely that there will be a COVID waiver that everyone attending the trial will need to sign. For the searches that are conducted in an interior setting, CDC guidelines regarding masks will be used to inform our decision making about any masking requirements for those searches.
